WHO WE ARE

Our mission at Master Provisions (MP) is to serve God by connecting resources to needs, uplifting one soul at a time for all generations.

We accomplish this through our vision of fully equipping and supplying our distribution center. Master Provisions provides resources to hundreds of agency partners who directly serve the community. This collaborative approach allows our nonprofit partners to save time and money obtaining resources. This, in turn, helps them focus on their missions of serving others.

WHO WE SERVE

In 2024, Master Provisions had 254 agency partners who directly served their communities in the OH/KY/IN/WV region. MP serves these agencies by rescuing and distributing food and other resources from big box stores that would otherwise be thrown away. 2,600,000 pounds of food were rescued and redistributed to our agency partners, working to end food insecurity and food waste. These local partners served approximately 77,550 people each month.

WHO SERVES WITH US

MP has over 300 volunteers who serve continuously. These volunteers work in the warehouse and the office in various roles. They have contributed 15,524 hours, which is equivalent to \$531,000 worth of donated time for 7.5 full-time positions.

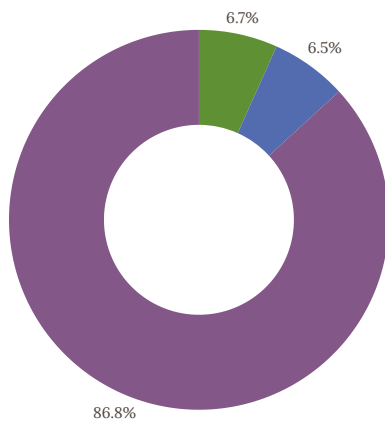
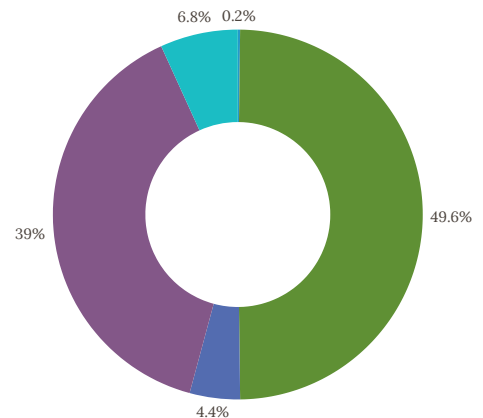
